# **TEACHING EXPERIENCE**

*Teaching Experience* – <u>Niagara University</u> – <u>Graduate Level</u>

MGT 651 Strategic Information Systems

**Course Description and Content:** This course introduces students to the dynamics of information technology (IT) applications and the challenges associated with integrating such applications into the modern business enterprise. Students learn about the integration of information systems (IS) into organizations for the benefit of employees, customers, managers, and executives. Particular emphasis is placed on stressing the strategic importance of IT for organizations' operations;

however students are also presented with the operational/support role of IT. In this class, student also learn to appreciate the ethical and moral issues associated with IS/IT use. *Course taught consecutively 3-5 sections a year from Spring 2010 until present* 

#### MGT 672 Creative Problem Solving

**Course Description and Content:** Edward deBono said: "Creative thinking is not a talent, it is a skill that can be learnt. It empowers people by adding strength to their natural abilities which improves teamwork, productivity and where appropriate, profits." This course builds on this by exploring convergent, divergent and design thinking and other tools to creatively address organizational problems.

#### Course taught consecutively 1 section a year from Fall 2017 until present

#### MGT 670 People in Organizations (co-taught, 2 Professors)

**Course Description and Content:** This course provides today's managers with the background and skills necessary to lead and motivate an increasingly diverse, team-based work force. Topics include the structuring of effective teams, leading and participating in teams, communicating with and motivating others, and recognizing and valuing individual differences. Using current theories from the social and behavioral sciences, students are provided with negotiation techniques. The course also requires working cooperatively in effective teams, which is an important element of the Niagara University MBA program as it is also a requirement of all managers in private, public and nonprofit organizations. *Course taught one time - Spring 2010* 

Teaching Experience - Niagara University – Undergraduate Level

#### MGT 308 Ecommerce Essentials

While introducing the overall concept and impact of e-commerce, the emphasis of this course is to understand the opportunities, challenges, and initial steps required to establish an entrepreneurial web based business. Students work on establishing a profitable business throughout the semester and finish the class with an e-commerce business.

Course taught once a year consecutively from Spring 2014 until Present

VSJ 110 - Social Entrepreneurship for Change

Social entrepreneurship can play a significant role in addressing economic and social inequities. The UN has identified 17 sustainable development goals and this course will discuss how business can be used as a vehicle to address these goals. From eradicating hunger to bringing education to remote areas of the world, businesses can be a vehicle of change. *Course taught Fall 2022* 

#### MGT 390 Operations and Information Systems Management

**Course Description and Content:** Introduction to Management Information Systems covering topics such as: IS and globalization, IS investments, IS infrastructure, e-commerce, IS security, business intelligence, systems analysis and development, IS ethics and crime, IS software and hardware, database, networking, the Internet and the World Wide Web. Additionally the course provides an overview of the role of information systems in operations management and supply chains. Lastly, students learn how to use Microsoft Office Excel and Access for appropriate data analysis and business intelligence.

#### Course taught consecutively 4 times a year from Fall 2009 until Spring 2016

#### BUS 120 Introduction to Business (co-taught, 4 Professors)

Course description and content: This course is designed as an introduction to business course for first year business students. Major topics include the competitive global business environment, successful firms and business leaders, business ethics, leadership and team skills, and an overview of the functional management areas of business and related career opportunities. **Personal responsibilities (2013, 2014):** Course Coordinator, Student Ombudsperson, Grade Manager and responsible for Guest Lectures

**Personal responsibilities (2010 & 2011):** Student Ombudsperson, Grade Manager, and Assistant Course Coordinator

*Course taught once a year consecutively from Fall 2010 until Fall 2015* 

#### BUS 231 Business Statistics II

**Course Description and Content**: Students are introduced to practical applications of statistics to business. Topics covered include hypothesis testing, non-parametric statistics, chi-square, multiple regression, and statistical process control. Students are required to complete a project applying advanced statistical methods to analyze quantitative information of the business world and demonstrate his/her problem solving and decision making skills. This course is <u>computer integrated</u> in which Microsoft Excel and other statistical packages are used. *Course taught once - Fall 2009* 

#### NUB 102 NU Beginnings

**Course Description and Content**: First semester students complete a 1 credit course that allows them to gain better understanding of what it means to be a freshman in college. They learn various skills including oral and written presentation, proper citation techniques, etc. *Course taught in the fall of 2011, 2012 and 2017*

Content: Introduction to Management Information Systems covering topics such as: IS and globalization, IS investments, IS infrastructure, e-commerce, IS security, business intelligence, systems analysis and development, IS ethics and crime, IS software and hardware, database,

networking, and the Internet. This course also covered Microsoft Office applications and use of MyITLab.

Course taught - Summer 2008, Spring 2008 and Fall 2007

MIS 374 Telecommunications and Networking in Business

Content: Data communications; infrastructure, and protocols; network topologies and management; network technologies and design, network security, business applications of communication technologies.

Course taught once - Spring 2007
